

### **WELCOME TO SWITZERLAND!**

Free morning and lunch at your leisure (own expense) in Geneva.

Tip: Taxis in Geneva are very expensive and due to the traffic conditions even a short trip can cost a lot. Public transportation is well organised (between airport and city you have many choices: train, bus, trolleybus).

The day on your arrival at the airport, you can get a free ticket to go to the city. The ticket machine for free ticket is located at the luggage retrieval hall and prints the free ticket without requirements or limitations upon the pressing of the button. Free ticket entitles You to take an airport train (train from the airport to the center), bus, tramway.

If you sleep in Geneva, when checking-in in your hotel, ask for a free transportation pass, valid for your whole stay!

**13:45** Transfer by comfortable coach, along the Lake of Geneva, to the « Swiss Riviera » (Lausanne-Montreux).

**15:30** (approx.) Arrival in Lausanne-Ouchy, Hotel Mövenpick.
