Withdrawal of membership rights

I regret to inform you that this is a kind written reminder to ask you to consider renewing your membership on or before Saturday 31 October 2020 OR advise us you will not be renewing, otherwise the Council has most unfortunately no option but to:

1. Withdraw the prestige of your Fellow status with postnominals and all SNV member rights and privileges and request the immediate return of the Fellow certificate to the Honorary Secretary - Mr Adewale Oladejo, Visatec Legal, Level 1, 1 Queens Road, St Kilda Road Towers, Melbourne, 3004;
2. In the future, should you wish to rejoin, impose an additional joining fee, requiring the Council approval process, where we offer a moratorium until 31 October 2020

3. Remove your details for voting rights, the e-bulletins, participation in CPD and other events, access to merchandise [new ID card, plaques, decals, ties and cufflinks, scarves and publications], members' concessions and the SNV website online directory (Search for a Notary) and the Members Only section with Practice Notes and resources and so much more;
4. Delete your details from the next Law Institute Diary Notary section (only current SNV members are included).

We sincerely hope that you will return to membership, participate and promptly pay the \$150 fee by completing the form with 3 payment methods for your convenience.

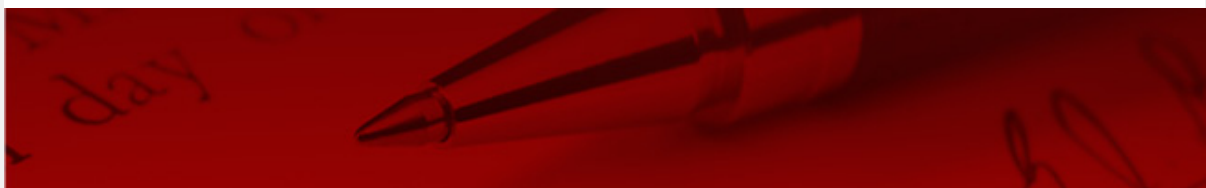
